NMA Speech Contest for High School Students

For the 28th year, the Boeing chapters of the National Management Association in Southern California have conducted an annual NMA Leadership Speech Contest for high school students. This year, the event is sponsored by Boeing Leadership Association of Southern California (BLASC). The event is a morning event: **Saturday, March 12, 2016**, at the Boeing Conference Center in Huntington Beach. The contest begins at **9:30 AM**. Light refreshment will be provided.

When it began in 1988, the speech contest was a little more than a vision. It resulted from chapter initiatives in sponsoring local essay and speech contests. The then named American Enterprise Committee’s response was to create a national speech contest.

Today, with continued support from members and chapters along with corporate donors, the contest has become a premier youth and community program for NMA...The Leadership Development Organization. The contest involves young men and women in grades 9 - 12. They research, write, and then deliver a 4-6 minute speech based upon their interpretation of a variety of Leadership topics. Topics such as Leadership in the world, its application to the free enterprise system and what Leadership means to them personally are some examples of speech themes. In short, the students are limited only by their imagination and creativity. Students report to us that participation in this contest increases their awareness and understanding of Leadership. The contest provides an incentive for the development of communication skills – vital to those preparing to enter the workforce. In communities across the country, the NMA Contest has become recognized as an innovative program supporting our young people.

The financial rewards, at all levels of the competition, contribute to students' furthering their education. NMA members take enormous pride in their program and herald the contest as one of the NMA's greatest contributions to understanding the various aspects of Leadership.

The NMA Leadership Speech contest is based on four levels of competition and is aligned with the NMA's six geographic areas which are: Northeast, Southeast, and Central (contestants compete at the East Chapter Leadership Training); Southwest; Pacific South and Pacific North (contestants compete at the West Chapter Leadership Training). The National Association of Secondary School Principals has placed this program on the NASSP national advisory list of student contests and activities for 2015-2016.

We sincerely invite you to attend this contest and see talented young people, dedicated volunteers, and enthusiastic family and friends. If you are interested in attending, please contact Daniela Nau at daniela.nau@boeing.com by Friday, March 4.

NMA Awards

As a reminder, the following award nomination forms are available on the NMA website (<http://www.nma1.org/chapter-and-council-awards-forms/>). Be sure to follow the instructions included in the forms. All forms should be emailed to the NMA Dayton office in Word files. Nominations should be submitted to the NMA Dayton office:

Executive of the Year	due 6/1/2016, requires SCAC endorsement
Hall of Fame	due 6/1/2016, requires SCAC endorsement
Member of the Year	due 6/1/2016
Publications	due 5/1/2016
Silver Knight	due to NMA 60 days before presentation date, requires approval by chapter national director



SCAC Awards

SCAC also offers awards. The April due date allows SCAC time to process the nominations and have plaques available to present at chapter meetings in the May/June timeframe, and/or to meet the Dayton due date of 6/1/2015 (particularly for Member of the Year nomination). Nominations should be submitted to Avis French (eavis@cox.net):

SCAC Member of the Year	due 4/15/2015 (use NMA form)	
SCAC Chapter Innovation	due 4/15/2015 (form available)	
SCAC Manager of the Year	due 4/15/2015 (form available)	
SCAC Gold Knight	(use NMA form) due to NMA 60 days before presentation date, requires approval by council national director	

Notes: Some chapters choose to send their chapter Member of the Year nominations directly to NMA for processing and also send their chapter Member of the Year nomination to SCAC for consideration as SCAC Member of the Year. The chapters are welcome to do so. The member selected as SCAC Member of the Year is automatically forwarded to Dayton for consideration as national Member of the Year.

- Be sure to follow the instructions included in the nomination forms. All forms (those requiring SCAC endorsement or those being SCAC nominations) should be emailed to Avis in Word files even if you used the forms on the NMA page (please use .doc format rather .docx format as some of our SCAC members cannot open .docx files).

- Remember, the awards listed in this newsletter are standard NMA awards. If you would like to recognize someone for special recognition, there are many special certificates and awards available for purchase on the NMA Awards page.

NMA Announces MyNMA Member Registration

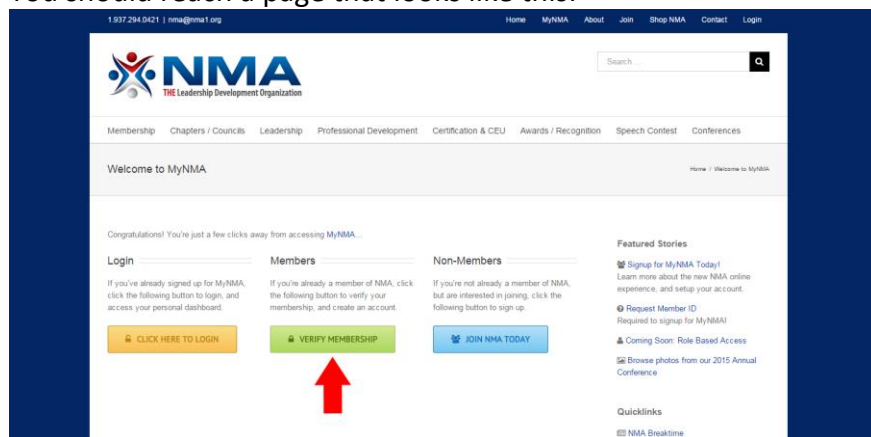
During the 2015 NMA Annual Conference, NMA announced the official launch of MyNMA. To make the NMA website more interactive, now you can create an account on the website. Every member who registers for the website will have access to a personal dashboard and a customized user profile.

MyNMA Signup Instructions:

First, click the link that reads "MyNMA" in the top-right hand corner of the website.

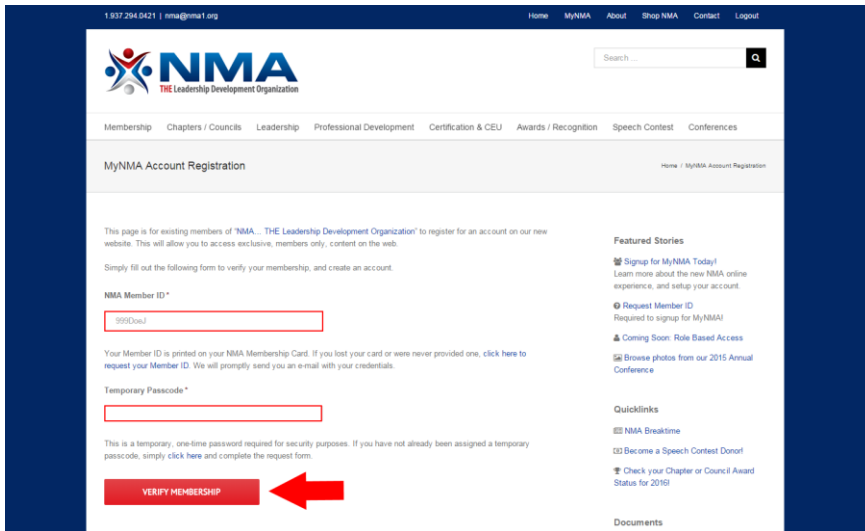


You should reach a page that looks like this:



Because you are already a member of NMA, click the green button which reads "Verify Membership" to continue, verify your membership electronically, and register for an account on our new NMA website.

You will then be re-directed to another page which looks like this:

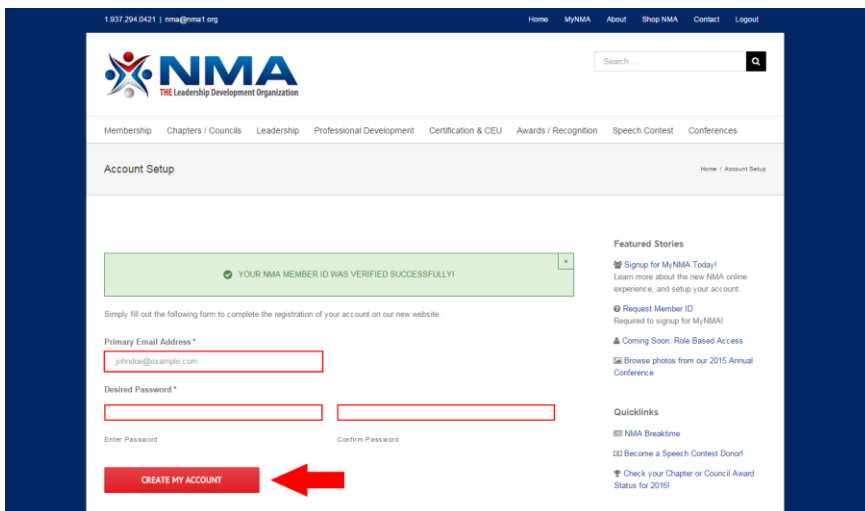


Enter your NMA Member ID and your temporary passcode, then click the red button which reads "Verify Membership" to continue.

If you don't know your Member ID, [click here to request your credentials](#). (Alternatively, there is a link in the sidebar which reads "[Request Member ID](#).") After completing a simple form, someone from NMA Headquarters will respond to you in a timely manner.

The temporary passcode is **nma2015!!** (case sensitive)

Finally, you will reach a page which looks like this:



This is the final step in registering for your MyNMA account. Enter your primary e-mail address, and your desired password. Then click the red button which reads "Create my Account."

...and that's it! Welcome to MyNMA!

You will now be able to login to the website, and access your personal member dashboard.
